

FAMILY RESIDENT VISA - PROCESS & REQUIREMENTS

1. The Copy Of Visa Slip ([Click For Sample](#))
2. Sponsor's (In this case yours) Passport Copy (First Page & Last Page)
3. Sponsor's Work Permit (Aqama) Copy
4. Original Passport of the person, there should be min.8 month Validity in the passport.
5. Color Photos – 12 Nos. (White Background, Size 4x6 cm)
6. Medical Report from the GCC Panel above 12 Year Child
7. Polio Certificates Required for all children below 12 Year. Must attested by Saudi consulate before submit to endorsement of visa. (Now a day Saudi Consulate insisting these format in the Polio Certificate).([Click For Sample](#))

N. B : In wife's passport if husband's name is **not** there as the name of the spouse, then original marriage certificate duly attested by the Saudi Consulate is needed.
